The *Hieratic Studies Online (HSO)* is a peer-reviewed, academic journal dedicated to presenting research on all aspects of hieratic and cursive hieroglyphs, for example:

- writing materials and techniques
- the system of the Ancient Egyptian cursive scripts
- development and interconnections between cursive and monumental scripts
- palaeography of signs from single scribes, texts, periods, or regions
- any sources of handwritings and hieratic inscriptions
- text editions
- new readings
- manufacturing of and copying features
- layout, extratextual notes, corrections, additions, marginalia

HSO is open-access: All articles in this journal can be viewed and downloaded free-of-charge.

HSO has an open format: Accepted papers will be published as soon as possible. There is no defined publication schedule or deadlines. With support of the authors or editors, also substantial monographs or proceedings may also be integrated in the publication process.

HSO offers scholars the opportunity to include a large number of colour images where appropriate to the article.

HSO is edited by the team of the project „Altägyptische Kursivschriften“ at the Mainz academy of Sciences and Literature.

How to submit

Languages: Submissions should be written in English, German, or French. Please let your manuscript be checked by a native-speaker if the chosen language is not your mother-tongue.

Summary, keywords, email-address: Please add an English abstract at the beginning (maximum 10 lines resp. up to 150 words), and choose up to ten keywords which can also be found in the keyword index of OEB. We may modify abstracts and keywords if necessary. Please also supply an email address which will be published with the article, so that readers can contact the author(s).

Contact details: Send your submissions or any queries to aku@uni-mainz.de and include full contact details (postal, telephone, mobile) so that we can contact you with queries about your article. Of course contact details are treated with respect and will not be published nor made accessible online.

Format: Please send your submission to us by email as a Word (*.doc or *.docx) document (other formats may be possible after approval), with images and artwork supplied on a CD, or via a web-hosted service for transferring large files. If any content needs to be arranged in a specific format, such as a complex table or chart, please send a pdf of how the chart should look, so that we can ensure material is not lost during migration between formats. Format of main text:

Please use Garamond 12p. or Calibri 11p. for the main text, and put the number of footnotes behind the point or comma, if not referring to a single word or part of a sentence.

Please put citations of original text passages in quotations marks.

Please italicise Latin or other foreign language words: *quasi*, *editio princeps*, *sic*, *recto*, *verso*, *kitāb*, etc.

French É is to be written with accent, also in abbreviations: Égypte, RdÉ, CdÉ, BdÉ, ÉAO, ASAE

Format of references in footnotes:

Please use only surnames (exceptions I./P. Munro, Di./Do. Arnold, J. P./Th. G. Allen etc.) and short titles or the location of the paper. Please use small capitals for surnames and cursive for the title of book resp. the journal:
